

**Cabinet Decision No. 132/2023 Concerning the Administrative Sanctions Imposed on the Violators of Cabinet Decision No. 109/2023 Concerning the Regulation of Real Beneficiary Procedure**

**The Cabinet,**

Having reviewed the Constitution;

Cabinet Decision No. 58/2020 Concerning the Regulation of Real Beneficiary Procedures;

Cabinet Decision No. 53/2021 Concerning the Administrative Sanctions Imposed on the Violators of Cabinet Decision No. 58/2020 Concerning the Regulation of Real Beneficiary Procedure: and

Based on proposition of the Minister of Finance and approval of the Cabinet;

The following is resolved:

**Article 1 - Definitions**

In application of the provisions of this Resolution, the following words shall have the meanings assigned to them respectively, unless otherwise is required by the context:

- **State:** United Arab Emirates.
- **Ministry:** Ministry of Economy.
- **Minister:** Minister of Economy.
- **Decree-Law:** Federal Decree-Law No. 20/ 2018 Concerning Anti-Money Laundering and Combating the Financing of Terrorism and Financing of Illegal Organisations.
- **Executive Regulation:** Cabinet Decision No. 10/2019 Concerning the Executive Regulation of Federal Decree-Law No. 20/2018 Concerning Anti-Money Laundering and Combating the Financing of Terrorism and Financing of Illegal Organisations.
- **Registrar:** The competent body that supervises the registry of trade names for different kinds of establishments registered in the State, including the Licensing Authority.
- **Concerned Entities:** Government entities concerned with the implementation of any provision of the Decree-Law and Implementing Regulation..
- **Real Beneficiary:** The natural person to whom the final ownership passes or exercises control or other indirect means as well as the natural person on whose behalf the transactions are conducted or who exercises actual final control over a Legal person, determined in Article (5) of Cabinet Decision No. 58/2020 Concerning the Regulation of Real Beneficiary Procedures.
- **Nominal Management Member:** Any physical person acting as per the directives, instructions or will of another person, duly appointed or occupying a post in the legal person. It is usually a representative of shareholders, members, or any other party with an interest .
- **Senior Management:** Decision-making authority at the legal person.
- **Record of Real Beneficiary:** Special record of real beneficiaries in the Legal person that contains all their data.
- **Record of Partners or Shareholders:** Special record of partners or shareholders in the Legal person that contains all their data.
- **Written Notice:** An official announcement sent to a legal person or his representative through legally available means

**Article 2 - Scope of Effectiveness**

The provisions of this Resolution shall apply to the Legal persons licensed or registered in the State, including non-financial free zones, in violation of the provisions of the Cabinet Decision No. 109/2023 Concerning the Regulation of Real Beneficiary Procedures.

**Article 3 - Administrative Sanctions**

1. Without prejudice to any penalty or procedure provided in the Decree Law and other related legislations, the Minister or any licensing authority delegated thereby may impose administrative sanctions on the violators of the provisions of the Cabinet Decision No. 109/2023 referred to, according to the offences and sanctions set out in the Table attached hereto.
2. In addition to the fine penalty imposed on violations committed for the third time, listed in the table attached to this decision, the registrar has the right to suspend the commercial license and close the commercial store of the violating legal person, provided that this suspension is lifted after he pays the fine imposed on the violation and corrects it by fulfilling the necessary requirements in the subject of the violation.

#### **Article 4 - Change of Penalties**

Any changes to the penalties set out in this Resolution, by addition, excise or change, shall be made by the Cabinet.

#### **Article 5 - Quotas of the Federal Government and Governments of Emirates in the Revenues of Administrative Sanctions**

Resolution that determines the proportions of division of the administrative sanctions described in this Resolution between the Federal Government and Governments of Emirates shall be issued by the Cabinet, based on proposition of the Minister of Finance, after coordination with the Minister and licensing authorities.

#### **Article 6 - Closing Provisions**

1. The penalties set out in this Resolution shall be collected by such means determined by the Ministry of Finance.
2. For purposes of collection of administrative penalties set out in this Resolution, a part of day shall be deemed a whole day and a part of month shall be deemed a whole month.

#### **Article 7 - Executive Decisions**

In coordination with the licensing authority, the decisions and procedures necessary to implement the provisions of this Resolution shall be issued by the Minister.

#### **Article 8 - Abrogations**

Cabinet Decision No. 132/2023 Concerning the Administrative Sanctions Imposed on the Violators of Cabinet Decision No 58/2020 on the Regulation of Procedures Related to Real Beneficiaries, as well as any provision contrary to or inconsistent with the provisions of this Decision shall be abrogated.

#### **Article 9 - Publication and Enforcement of the Resolution**

This Resolution shall be published in the Official Gazette and shall come into force from the day following the date of issue.
