| Intimation                          | <ul> <li>NOC should have been issued by Labour Dispute Office when the member filed the dispute.</li> <li>The court/lawyer of the deceased will notify RAKINSURANCE of the death during the dispute period.</li> </ul>   |
| Documents required for adjudication | <ul> <li>Duly filled and signed Claim Questionnaire</li> <li>NOC issued by Labour Dispute Office</li> <li>Final court verdict</li> <li>Death Certificate copy</li> <li>Passport and visa copy</li> <li>Copy of embalming certificate and proof of embalming charges</li> <li>Receipt for ambulance charges</li> <li>Proof of payment for coffin box charges</li> <li>Proof of payment for airfreight charges and airway bill</li> <li>Copy of air ticket for the accompanying person (if any) and proof of payment for the air ticket charges</li> </ul> |
| Turnaround time for adjudication    | 2-5 business days (depending on the number of cases)   |
| Turnaround time for settlement      | 1 business day   |
| Turnaround time for payment         | 1 business day from settlement   |
