1. Purpose

The purpose of this document is to ensure proper compliance and maintain best practices in the supply of the below high-risk supplies:

- Rental Lifting Equipment
- High Risk Supplier (Vehicle-carrying Gas Cylinders and industrial Fuel/Gas Supply Tankers)

2. Scope

This guide applies to all rental and high-risk suppliers to supply within the RAKEZ jurisdiction.

3. Definitions

- **HS&E Department** – Health, Safety & Environment Department
- **RAKEZ** – Ras Al Khaimah Economic Zone - Government of Ras Al Khaimah
- **RAK CD** – Ras Al Khaimah Civil Defence

4. Procedure

4.1. Procedure for obtaining NOC for Rental Lifting Equipment

- The NOC application form shall be submitted to RAKEZ HS&E Department by clicking [here](#) along with the following documents:
 - Copy of valid load test from RAKEZ registered consultants
 - Copy of equipment registration
 - UAE Trade Licence (*applicable for new supplier registration*)
- Upon receipt of the application, a sales order will be issued with service fees as per the HS&E Service fees – (HSE-SF01).
- Upon confirming the payment and satisfactorily completing the submission of the documents, the NOC shall be issued subsequently within **two (2) working days**.
- In case any amendment is required for the NOC, the supplier shall apply for amendment NOC application by clicking [here](#).
- Upon the expiry of the NOC, the supplier shall apply for renewal NOC application by clicking [here](#).
- In case cancellation is required for the NOC, the supplier shall apply for cancellation/suspension of NOC by clicking [here](#).

4.2. Procedure for obtaining NOC High Risk Supply

- The NOC application form shall be submitted to RAKEZ HS&E Department by clicking [here](#) along with the following documents:
 - Copy of equipment registration
 - Copy of driving licence
 - Copy of valid RAK Civil Defence NOC
 - UAE Trade Licence (*applicable for new supplier registration*)
- Upon receipt of the application, a sales order will be issued with service fees as per the HS&E Service fees – (HSE-SF01).
- Upon confirming the payment and satisfactorily completing the submission of the documents, the NOC shall be issued subsequently within **two (2) working days**.
- In case any amendment is required for the NOC, the supplier shall apply for amendment NOC application by clicking [here](#).
- Upon the expiry of the NOC, the supplier shall apply for renewal NOC application by clicking [here](#).
- In case cancellation is required for the NOC, the supplier shall apply for cancellation/suspension of NOC by clicking [here](#).
