1. Purpose

The purpose of this document is to systematically measure and recognise the excellence in health, safety, and environmental practices, motivating continuous improvement in HS&E performance.

2. Scope

This guide shall apply to all clients operating in land and warehouse facilities within RAKEZ's jurisdictional areas.

3. Definitions

- a. **HS&E Department:** Health, Safety & Environment Department
- b. **RAKEZ:** Ras Al Khaimah Economic Zone

4. NUJOOM AL SALAMA Scheme

The rating will be assigned in accordance with the criteria outlined below.

Rating	Criteria	Application Submission Month	Validity
3-Star	Click on the checkbox for questions 1 to 10 with supporting evidence	31 st August	Three Years
4-Star	Click on the checkbox for questions 1 to 20 with supporting evidence	31 st August	Three Years
5-Star	Click on the checkbox for questions 1 to 30 with supporting evidence	31 st August	One Year

Please note that clicking the questions in a non-sequential manner will not contribute additional weight to the application.

5. Procedure

- The application shall be submitted to the RAKEZ HS&E Department by clicking [here](#) along with the evidence documents if 'Yes' is selected for the questions. Only one application can be submitted in a year.
- A presentation shall be submitted that showcasing the company's contribution towards Health, Safety and Environment for the 5-star ratings applications.
- Upon receipt of the application and satisfactorily completing the submission of the evidence, the star rating certificate shall be issued subsequently within thirty (30) working days.

6. NUJOOM AL SALAMA Upgrade

The client will be able to upgrade the existing health and safety rating after one year (365 days) of holding the current rating by sending the application form along with the evidence documents to by clicking [here](#).

7. Non-Compliances with Criteria

- RAKEZ reserves the right to conduct audits at its discretion to oversee and ensure overall compliance with health and safety rating criteria at any time.
- RAKEZ reserves the right to revoke the certificate, if the client fails to comply with applicable regulations or if it is deemed necessary.
